- Must either have a current psychological and physical examination on file with your current law enforcement agency demonstrating your ability to be employed as a peace officer (completed within 3 years prior to the date of hire by our office), or be able to pass these examinations prior to being hired by our office.

- Have a thorough knowledge of the Colorado Revised Statutes and be familiar with court procedures
- Have the knowledge and skill required to quickly write search and arrest warrants that effectively establish probable cause under strict time constraints and under stressful conditions.

   Outlook, Adobe Acrobat, and be able to learn to use a variety of search engines,

databases, and case management applications.
