PEOPLE V. BRYANT CHARGE SUMMARY

The District Attorney's Office filed charges today against Edward and Linda Bryant. Both are charged with class 3,4, and 5 felonies (see below).. The possible penalty for a class 3 is 4-12 years in the Department of Corrections a class 4 is 2-6 and a class 5 is 1-3 years. Linda Bryant will be back in court on March 31st at 8:30 a.m. for a Motions Hearing and Edward Bryant is set for a Motions and Bond Reduction Hearing on April 21, at 8:30.
